

European Volunteering Capital 2018 Application Form #EVCapital

CEV launches the fifth edition of the European Volunteer Capital competition. The award is chosen from the applicant municipalities by an international jury of experts who assess the extent to which the recommendations as listed in PAVE are shown to have been implemented. The information provided in this form will count as 70% of the final score allocated to each candidate. 30% of the score will be allocated based on the presentation of the candidature during the Candidates Reception organised by CEV and London European Volunteering Capital 2016 on 13 October 2016 in Brussels (BE).

Important Steps:

1 February 2016 Open call for applications 30 June 2016 Deadline for applications

1 July 2016 Candidates announcement on social media

July / August 2016 Appointment of the Jury & preparation of the presentation of candidatures reception.

13 October 2016 Presentation of Candidatures as part of the CEV PIPE Conference in Brussels, Belgium.

December 2016 Announcement of the European Volunteering Capital 2018 Winner

The Policy Agenda for Volunteering in Europe (PAVE) document in various languages is available on the CEV website here. If the language needed is not there please enquire with the CEV office.

The application form needs to be completed in English with information on volunteering policy and practice in your municipality. The sections reflect the four policy recommendation areas of PAVE:

- An enabling and facilitating environment for volunteering
- Quality in volunteering
- · Recognising volunteering
- Valuing volunteering

You are encouraged to familiarise yourself with them as it will assist in making your application. You are also encouraged to liaise with relevant stakeholders in preparing your application such as Volunteer Centres.

Please distinguish between support and / or situation that exist only in your municipality or when it is the case nationally or regionally.

Good to know:

Municipalities that have been awarded the title of "European Volunteer Capital" cannot apply for the next 5 years after having received this recognition.

The jury appointed by the CEV secretariat acts in full autonomy. Jury members with any conflict of interest in judging will not evaluate these candidates. The decision of the Jury awarding the European Volunteering Capital for 2018 will be announced on or near 5 December 2016- the International Volunteer Day.

The Call for Appllications for the 2019 Competition will be published in February 2017.

The winning municipality will be required to sign a Memorandum of Understanding with CEV reflecting the agreed framework for cooperation for the year the title is awarded.

All candidate municipalities will receive a certificate of candidacy.

Guidelines for Submission of the Application Form European Volunteer Capital 2018

Objectives: The European Volunteering Capital Competition 2018 aims to promote volunteering at local level by giving recognition to municipalities which support and strengthen partnerships with volunteer centres and volunteer involving organisations in their communities in implementing the recommendations of the Policy Agenda for Volunteering in Europe (PAVE). The winning municipality will be granted the title of "European Volunteering Capital 2018" and will be promoted as such during 2017 and 2018 throughout Europe and beyond.

Deadline: 30 June 2016

Eligibility: Municipalities of any size from a member state of the Council of Europe.

Attachments:

1. Application Form*: This should be downloaded and completed digitally before printing. Once printed the form should be stamped with the official stamp (where available) and signed by the legal representative. The form should then be scanned and submitted by email. Character limitation includes spaces.


